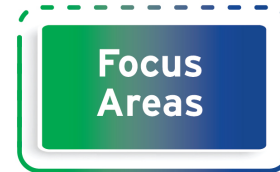

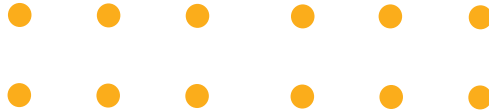

Factory Transformation Programme (FTP)

- This programme aims to assist timber companies in improving their manufacturing efficiency and productivity as well as towards Industry 4.0 ready through the application of Lean Manufacturing and other good manufacturing practices. The programme modules are based on manufacturing industry needs developed by the training providers.

FINANCIAL INCENTIVES

Technology Acquisition Programme (TAP)

1. Automation Technology Acquisition (ATA)

- To incentivise eligible manufacturers in the timber industry for the purchase of new machinery to upgrade their manufacturing processes, for the diversification of the company's product range as well as process line automation.

Eligibility Criteria

- The company shall be incorporated in Malaysia and based in Peninsular Malaysia with own manufacturing facilities.
- The company shall be a Malaysian-owned company (with at least 51% of shareholding).
- The Applicant Company shall be a member of any one (1) of the following six (6) Timber Associations:
 - Malaysian Wood Industries Association (MWIA)
 - The Timber Exporters' Association of Malaysia (TEAM)
 - The Malaysian Panel-Products Manufacturers' Association (MPMA)
 - Malaysian Wood Moulding & Joinery Council (MWMJC)
 - Malaysian Furniture Council (MFC)
 - Persatuan Pengusaha Kayu-Kayan & Perabot Bumiputra Malaysia (PEKA) [Association of Malaysian Bumiputra Timber & Furniture Entrepreneurs]
- The company shall be installed with wood-based manufacturing facilities and in operation for at least three (3) years.
- Must be involved in sawmilling or production of value-added timber products, or timber trading.
- To prioritise manufacturing companies specialising in timber products for export.
- Eligible for companies with an annual revenue from RM300,000 to less than RM100 million and are not public listed.
- Companies with common shareholders having different core businesses may apply (excluding Purchase of Material Handling Equipment), with a reimbursable amount as follows:
 - Purchase of new machine: RM70,000 each, up to RM140,000.
 - Purchase of reconditioned machine: RM50,000 each, up to RM100,000.
- Companies with common shareholders with similar core businesses may apply and share the eligible incentive.
- On-going projects where the machinery/system has been installed/in-operation are not eligible.
- Companies that have received other grant or subsidy for the purchase of the same item from other government or government-linked agencies are not eligible.
- All applicants must comply with Occupational Safety and Health Act (OSHA) regulations. According to the OSHA Order 1997, the woodworking industry, involving activities like cutting, sawing, planing, and shaping, is required to appoint a Safety and Health Officer (SHO) for each workplace with more than 100 employees.
- Under the Occupational Safety and Health Act 1994 (OSHA 1994):
 - Section 30(1)(a) mandates a Safety and Health Committee for workplaces with 40 or more employees.
 - Section 29A(1) requires an Occupational Safety and Health Coordinator (OSH Coordinator) for workplaces with 5 or more employees, unless an SHO is already mandated.
- The Graduation Policy applies, i.e. the recurring financial incentive is given up to a stipulated period of two (2) cycles¹ per company/group of companies.
- The number of cycles shall be determined by the company's participation in ATA [formerly known as Financial Incentive for Purchase of Machinery (FIPM)], following the launch of the FIPM programme in 2018.

Note: ¹ The duration of each cycle for the application year from 2018 to 2021 was three (3) years, whereas from 2022 onwards, it is two (2) years.
- Priority criteria:
 - New participating companies; and
 - Companies that participated in MTC Factory Transformation Programme (FTP) who are actively implementing its practices and/or companies undergone significant business transformation such as 5S, Lean Management, quality management, KAIZEN, and business digitalisation.
- Additional criteria for the subprogramme Special ATA Incentive for IR 4.0 Technology:
 - Companies must have successfully completed the MTC Factory Transformation Programme (FTP-Lean) or other equivalent programmes recognised by MTC, and must still be actively implementing its practices.
 - The company must have successfully completed the MTC Factory Transformation Programme (FTP-Step-up Lean), and must still be actively implementing its practices.
 - Priority will be given to companies that participated in the MTC Timber Reality Programme.
 - Preference will be given to high-impact investments.

FINANCIAL INCENTIVES

Technology Acquisition Programme (TAP)

1. Automation Technology Acquisition (ATA)

- To incentivise eligible manufacturers in the timber industry for the purchase of new machinery to upgrade their manufacturing processes, for the diversification of the company's product range as well as process line automation.

Incentives

Scopes and Incentive Categories:

A. To incentivise companies that purchase new woodworking machinery involved directly in the manufacturing processes to upgrade their manufacturing processes or to diversify the company's manufacturing capacity.

Type of Incentive	Entitlement
1. Matching Grant for companies with annual revenue from RM300,000 to less than RM2 million. <i>Limited to RM150,000 per company/group of companies (one-off).</i>	50%
2. Purchase of New Machine for companies with annual revenue from RM2 million to less than RM15 million. <i>Limited to RM70,000 per company/group of companies. Graduation policy applies.</i>	20%
3. Medium Impact Project (MIP) for companies with annual revenue from RM15 million to less than RM50 million. <i>Limited to RM150,000 per company/group of companies (one-off). *Minimum project value at RM350,000</i>	20%

B. To incentivise companies in acquiring new production line(s) with modern technologies for upgrading of manufacturing facilities and gearing towards Industry 4.0.

Type of Incentive	Entitlement
1. High Impact Project (HIP) for companies with annual revenue from RM50 million to less than RM100 Million. <i>Limited to RM200,000 per company/group of companies (one-off). *Minimum project value at RM700,000</i>	10%

C. To address timber industry's urgent needs for material handling equipment due to labour shortage. The programme is open for both SMEs and non-SMEs.

Type of Incentive	Entitlement
1. Purchase of Material Handling Equipment <i>Limited to RM100,000 per company/group of companies (one-off).</i>	50%

D. To support SMEs and non-SMEs in improving productivity via the purchase of reconditioned machine.

Type of Incentive	Entitlement
1. Purchase of Reconditioned Machine <i>Limited to a maximum of RM50,000 per company/group of companies. Graduation policy applies.</i>	10%

E. The Special ATA Incentive was launched on 1 August 2025 to encourage the adoption of IR 4.0 technologies by supporting access to cutting-edge machinery and innovations showcased at international trade fairs.

Import Assistance Programme (IAP)

 - Persatuan Pengusaha Kayu-Kayan & Perabot Bumiputra Malaysia (PEKA) [Association of Malaysian Bumiputra Timber & Furniture Entrepreneurs].
4. Eligible for both small and medium enterprises (SMEs) and non-SME companies.
5. Companies with 50% or more of majority common shareholders may participate in the programme.
6. Companies within the same group or with common shareholders but different core businesses are eligible to apply for up to a maximum of two (2) companies and/or reimbursement up to RM180,000. This term does not apply to the local traders.
7. Local manufacturers that purchase imported raw materials from domestic traders may apply.
8. Categories of eligible local traders are as follows:

10. The timber raw materials must be from legal sources.
11. Import of timber raw materials from Sabah and Sarawak is permitted under the programme. Timber materials that are eligible to be imported from Sabah and Sarawak are logs, sawntimber, veneer, panels, mouldings, semi-processed products and timber components deemed suitable by MTC.
12. Final port of destination should be a port located in Peninsular Malaysia.
13. Alternative raw materials from local sources (i.e. oil palm trunk, coconut trunk, kenaf, bamboo, etc.) are also eligible under this programme. Alternative raw materials sourced from its own plantation and related subsidiaries, or group of companies are not eligible under this programme.
14. MTC's Financial Incentive Guideline (formerly known as MTC Graduation Policy) applies to the Direct Sourcing Programme (DSP) under IAP, with the exception of raw materials imported from Sabah and Sarawak (until further notice).
15. The duration of financial assistance under the DSP is limited to a maximum of seven (7) years. This period is calculated from the year a company first participated in the DSP, with 2018 designated as the base year. A company is considered to have participated if it received reimbursement(s) in that particular year.
